#### **About Envision Illinois**

• Envision Illinois was funded in 2013 by the Office of Domestic Justice, Office on Violence Against Women to the Department of Human Services. The grant statewide collaborative project, addressing domestic violence against people with disabilities and Deaf people is transforming the system so that survivors have equal access to healing, safety, and justice.

#### **About Envision Illinois**

- The Mission of Envision Illinois is to transform services in Illinois into a survivor-centered, seamless, responsive, and sustainable system that fully meets the needs of Deaf people and people with disabilities who are survivors of domestic violence. We ENVISION a culture in Illinois in which Deaf people and people with disabilities who experience domestic violence are empowered by a system of inclusive, accessible, person-centered, and person-directed services that result in equal access to healing, safety, and justice.
- For purposes of this review tool, **Deaf**: refers to all categories of hearing loss: deaf, hard of hearing, late deafened, and deafblind and **People with disabilities**: refers to people with mental illnesses, intellectual and/or developmental disabilities, chemical sensitivities, and physical disabilities.

# Why is this important?

- People with disabilities/Deaf people are abused 4x more than people without disabilities/Deaf people.
- People with disabilities report experience of abuse less than people without disabilities/Deaf people.
- Domestic Violence programs' goal is to serve all survivors with the same equality of services.
- Centers for Independent Living are a great resource for domestic violence programs.

# Why is this important?

- CILs have the experience, resource, and expertise to conduct these reviews.
- CILs can get victims away from abusive caregivers.
- We can help more people through the Accessibility Responsiveness Review tool.
- Centers for Independent Living do exist.
- Local solutions, strategies, and resources can be recognized and utilized to address accessibility.

- Have Illinois Centers for Independent Living conduct reviews of Domestic Violence programs.

- Foster collaborative relationships, not only between Domestic Violence Programs and Centers for Independent Living, but with other agencies that work with people with disabilities and Deaf people.

## What to know about DV Programs

- 50+ domestic violence programs in Illinois
  - Most programs provide 24/7 shelter and crisis line.
- Common Services (in person and/or virtual)
  - Crisis line
  - Shelter and Economic Self-Sufficiency
  - Court/legal/medical advocacy
  - Counseling or therapy (individual or group)
  - Children's Services
  - Outreach/Prevention
- Intake process

#### What to know about CILs

- 22 CILs in Illinois (covering multiple counties)
- Run by and for the people they serve with 51% staff and Boards of Directors federally mandated to be comprised of people with disabilities.
- Cross-disability organizations
- Five (5) core services
  - Information and referral (I&R)
  - Independent living skills training
  - Peer support
  - Individual and systems advocacy
  - Transition supports
